The Act

The events of Sept. 11, 2001, reinforced the need to enhance the security of the United States. Congress responded by passing the Public Health Security and Bioterrorism Preparedness and Response Act of 2002 (the Bioterrorism Act), which President Bush signed into law June 12, 2002.

REGISTRO DE INSTALACIONES

(Food Facility Registration)



INSTALACIÓN (*Facility*)

Establecimiento o estructura (fábrica, planta, packing, factoría, almacén, etc.) donde se fabrican, manufacturan, procesan, envasan, acondicionan o almacenan alimentos que vayan a ser exportados a EE.UU.

INSTALACIÓN *(Facility)*

No es una instalación:

- Residencias particulares (garajes, patios, azoteas)
- Campos de cultivo o granjas de cría
- Vehículos de transporte (excepto los barcos-factoría de productos pesqueros)

LA LEY EXIGE QUE LAS INSTALACIONES SE REGISTREN ANTE LA FDA

- Todo propietario o persona a cargo de una instalación debe registrarla ante la FDA y Obtener su Número de Registro
- Puede autorizar a un tercero (importador, transportista, representante, exportador familiar, etc.) a realizar el registro en representación de la instalación.

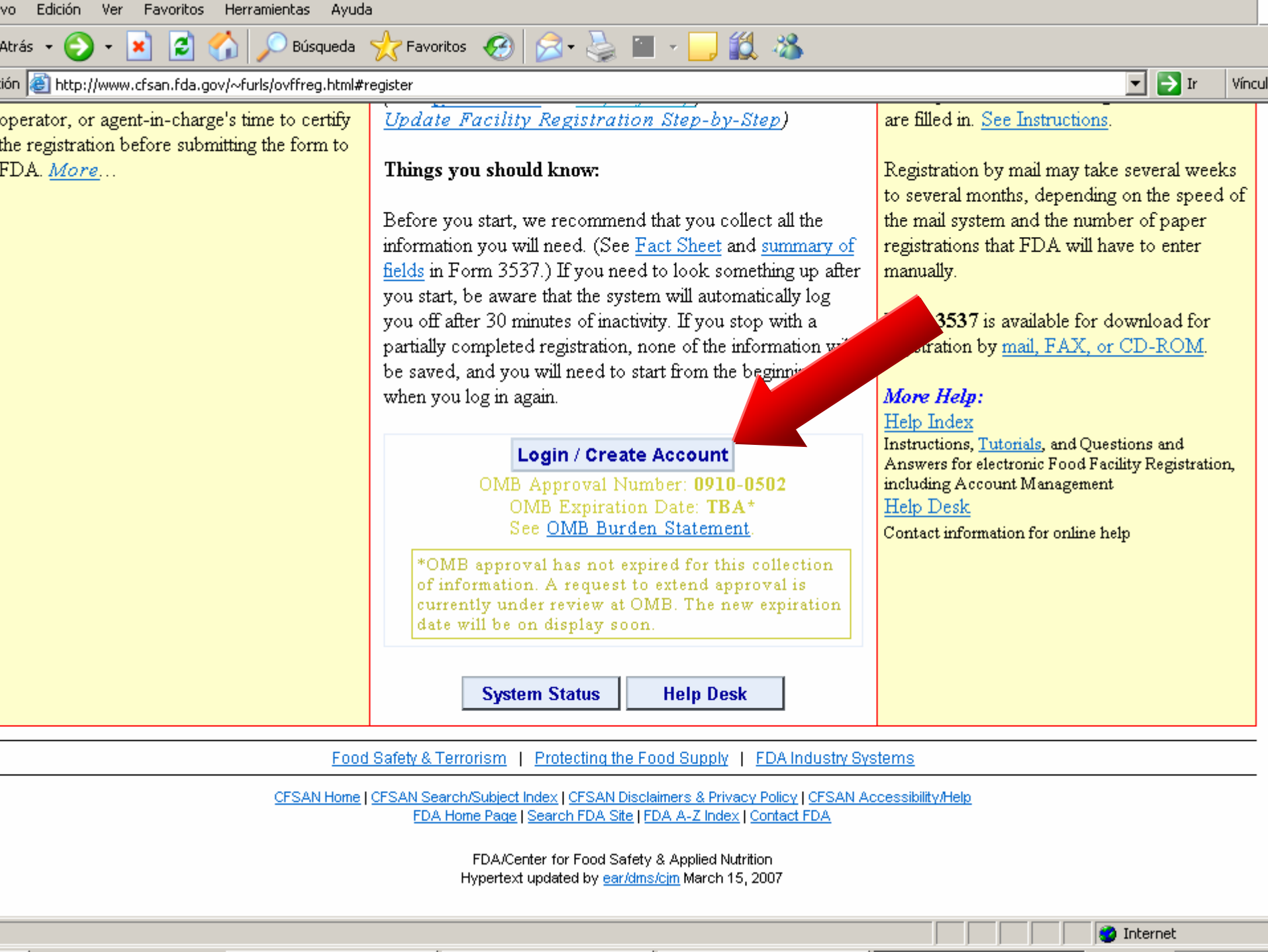

NOTIFICACIÓN PREVIA (Prior Notice)

- La Notificación previa es un aviso electrónico enviado a la FDA sobre los productos alimenticios que se exportan a EE.UU antes que éstos ingresen a territorio estadounidense

ENVIOS QUE REQUIEREN NOTIFICACIÓN PREVIA (Además de las exportaciones)

- Muestras comerciales y regalos
- Alimentos que transitan a través de EE.UU hacia otro país
- Alimentos enviados por correo o servicio de Courier
- Alimentos enviados para análisis de calidad.

ENVIOS EXENTOS DE NOTIFICACIÓN PREVIA

- Muestras de alimentos para análisis fisicoquímicos destructivos o que los imposibilita para un posterior consumo
- Alimentos para consumo personal de los viajeros.
- Alimentos preparados en casa de un viajero o familiares y transportados en el equipaje para obsequiar en EE.UU

ENVIOS EXENTOS DE NOTIFICACIÓN PREVIA

- Alimentos que se encuentren en tránsito en EE.UU, pero que no son sacados de los terminales aéreos o marítimos.
Ejemplo: vuelos haciendo escala en EE.UU

¿QUIÉN ENVÍA LA NOTIFICACIÓN PREVIA?

- Cualquiera de las partes que tenga conocimiento de la información requerida por la FDA (Puede ser el exportador, el importador, el transportista, el agente o inclusive un tercero designado por las partes)
- Es responsabilidad del exportador asegurarse que este trámite se realice.

¿CUANDO SE ENVÍA LA NOTIFICACIÓN PREVIA?

La Notificación Previa deberá enviarse entre **5 días** y:

- **Ocho Horas Antes** si arribará a EE.UU por vía marítima.
- **Cuatro Horas Antes**, si arribará por vía aérea o férrea.
- **Dos horas antes** si ingresará por vía terrestre.

Create New Web Entry

Creating a Web Entry is the first step in creating Prior Notices. A Web Entry contains information that one or more food articles you intend to import share (e.g., arrival information). After Creating a Web Entry, create, review, and submit Prior Notices. Prior Notices include information about the Product, its Quantity and Packaging, and other related information, such as the Manufacturer or Grower/Consolidator and the Shipper.

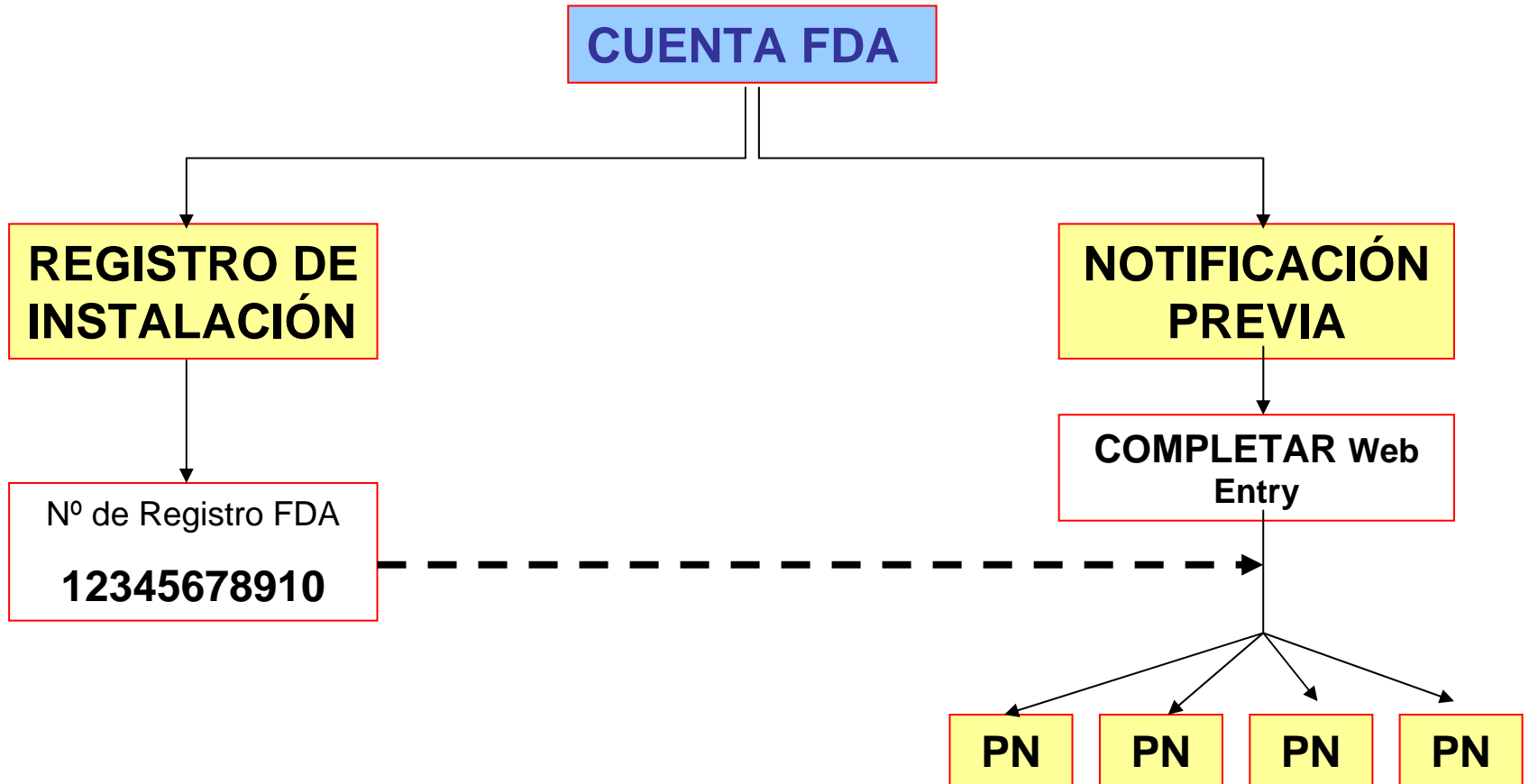

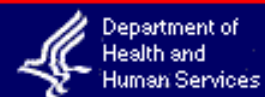
