

INCENTIVES

TAXES

- Exemption from: Income Tax (in general scheme amounts to 29.5% on profits), General Sales Tax (16%), Municipal Promotion Tax (2%) and Selective Consumption Tax (between 2% and 30%) % according to product type).

Ad valorem 0% to goods of foreign origin (raw materials, inputs, machinery, equipment) under the general regime the rates are 0%, 6% and 11%.

- Exemption of all taxes from the Central, Regional or Municipal Government to be created.

CUSTOMS

- Suspension of payment of import duties and taxes on machinery and equipment that user companies need for their production processes. These can enter the national territory paying taxes for their depreciated value.
- Entry and exit of merchandise by any Peruvian customs.
- The merchandise resulting from the maquila activity that returns to the national territory only pays the taxes for the incorporated value.
- Suspension of taxes for the permanence of merchandise until the year 2042.
- The Drawback benefit for export is applicable (4% of the FOB value exported).
- The export of processed products has commercial benefits due to the scope of the Free Trade Agreements (FTA).
